Daily Report

5 December 2017

The silent period for the second phase of parliamentary and provincial election has begun from the mid night of December 4. After the beginning of silent period, none of the political parties and candidates are allowed to do election related activities in 45 districts. If someone found to be asking votes during this period by any means will be taken action by the election commission. Along with the beginning of silent period in 45 districts, the political parties have expedited their personnel meetings with voters. The distribution of voters ID cards have begun in all districts.

The political parties have stopped their election activities after the beginning of silent period however the cadres were found to be mobilized in camps of free Haliyas, squatters and Kamaiyas camps to secure their votes. The distribution of voter's ID has begun from December 5 according to the election office. Polling staffs and employees are busy on all-party meetings including other activities in their respective polling centers. In bordering districts of India, borders are sealed and security has been tightened. Apart from few incidents, the election related activities are peaceful according to INSEC district representatives. This report is based on the information received from INSEC district representatives.

According to Morang District representative Indira Bhattarai, a Sutali bomb was recovered from Kadmaha road in Dhanpath Rural Municipality which was later disposed by a team of Nepal army according to CDO Bishnu Prasad Pokhrel. The voter's ID has been distributed in the district.

In Ilam, police have arrested 12 people from various parts of the district on charge of their involvement in anti-election activities. They were arrested from Chitwan, Kathmandu, Tanahu, Rupendehi, Terathum, and Sankhuwasabha. The voter's ID has been distributed from the polling stations of the district. The security is focused on how to give security during the election and during transferring the ballot box.

According to Sunsari district representative Shekhar Dhakal, a bomb has been exploded in Jwalamukhi Polling Center of Dharan Sub-metropolis-17 on December 5. Two unidentified people in a motorbike had thrown the bomb and fled the site however there was no destruction by the bomb according to DSP Rameshwor Paudel of Area Police Office of Dharan. The security of the district has been tightened assuming all polling centers being sensitive. The distribution of voter's ID has begun from December 5.

According to INSEC district representative Man Bahadur Chaudhary of Bardiya, an unidentified people have detonated a bomb near the house of Naya Shakti candidate Keshav Paudel at Bansgadhi Municipality-5. There was no human loss reported in explosion according to CDO Narayan Prasad Bhattarai. After the explosion, the locals of Bansgadhi are terrified. In free Kalaiya camp at Badhayatal-9, Nepali congress cadres were cordoned by the cadres of left alliance accusing them of giving feast. Team led by Nepali Congress leader Netra Bahadur Ranabhat and cadres were taken into control for some time by the left alliance. Police had opened three rounds of fire and released the cadres of Nepali Congress according to inspector Dendra Bahadur Malla of Area Police Office Mainapokhari. Leader Netra Bahadur was handed over to the police.

In Dang district, police have arrested 28 years old Hemanta GC and district secretary of ANNISU Amar Khadka on December 5 on charge of anti-election activities according to our district representative J.N Sagar.

According to Kapilbastu District representative Nanda Ram Paudel, the incidents of explosions have increased in the district along with the approaching day of election. In Badganga Municipality-6, Kopawa, a bomb was detonated targeting the house of Nepali Congress leader Duniya Bhushal in the night of December 4. The bomb was identified as a socket bomb according to police. There was a minor damage in the house due to the explosion. On the same evening a vehicle of Nepali Congress cadres was attacked with petrol bomb by an unidentified people during their campaign. There was no human loss on the incident according to police.

According to INSEC district representative Dirgha Khatri of Doti, the situation of the district remains peaceful despite of some possible clashed between the left alliance and democratic alliance. After the beginning of silent period, the parties are alleging each other in a social networking sites. The security of the polling centers has been arranged based on their sensitivity according to DSP Shiva Bahadur Singh.

In Kanchanpur, there was a bomb explosion in the house of Nepali Congress candidate for constituency number 3, Ramesh Lekhak ,on December 5. The bomb was detonated by an unidentified people who came in a motorbike according to the police.

According to Rabina Chaudhary, INSEC district representative of Kailali, an unidentified people have detonated the bomb near the house of HoR candidate Lekh Raj Bhatta. The bomb was detonated 300meters away from the house of the candidate according to Area Police Office Attariya. According to SP Binod Ghimire , the incident is under the investigation.

In Dadeldhura, the security of the district has been arranged based on the categorization according to CDO however, some incidents of explosions have been reported in the district.
